Re: Alberta Electric System Operator Responses to Stakeholder Comments – Notice of Administrative Amendments to the ISO Rules in Pursuit of Red Tape Reduction ("Red Tape Administrative Amendments")

On January 17, 2023, the Alberta Electric System Operator ("AESO") issued a Letter of Notice notifying Stakeholders of its proposed Red Tape Administrative Amendments and requesting Stakeholder comments on the Red Tape Administrative Amendments.

The AESO's received comments from Morgan Stanley, Powerex Corp., TransAlta, and TransCanada Energy Ltd.

AESO Responses to Stakeholder Comments

In accordance with Section 11.3 of Alberta Utilities Commission Rule 017, Procedures and Process for Development of ISO Rules and Filing of ISO Rules with the Alberta Utilities Commission ("AUC Rule 017"), the AESO is providing replies to Stakeholder comments.

The AESO agrees with the comments received from Morgan Stanley, Powerex, TC Energy and TransAlta and has amended Sections 304.9, 203.6, and 103.2 accordingly.

The AESO also notes that, further to the Red Tape Administrative Amendments to Section 304.9 *Wind and Solar Aggregated Generating Facility Forecasting*, Table 1 has been amended to remove the column for *Height of Instrument Set-2*. This amendment aligns with the initial amendment to subsection 4(2).

Application for Approval of the Final Proposed Red Tape Administrative Amendments

Pursuant to Section 12.1 of AUC Rule 017, the AESO considers it has addressed stakeholder comments and expects to submit its application for approval of the proposed Red Tape Administrative Amendments with the Commission on or before March 20, 2023.
