Please advise and be as specific as possible.	Technical Session 1 was valuable as it allowed all parties to undertand the problem as seen by the AESO, DFOs and DCGs. All of the presentations by these three parties were consistent concerning the problem. The AESO provided good foundational background information on the substation fraction methodology, but could have used more time to walk through more examples that were similar to the review and variance application issues.
2.	Please comment on the <b>Technical Session 1 Summary Feb. 27 2020</b> . Is there information you felt was covered during the session that has not been represented in the summary? From the comments and discussion summarized by the AESO it appears that clarity on how the existing substation fraction works in different situations is an issue. There are different understandings of how the substation fraction is applied by the AESO for allocating costs for new facilities and for changes to existing substations. More examples concerning the review and variance applications would have helped.
