9:10 am	2. Discussion Item: Impacts of GoA decision
	Doyle Sullivan noted the GoA decisions and invited discussion on impacts and whether any of the learning could be brought forward to include in the current TDAG and Transmission WG. Participants noted:
	 John Martin has always been very good at providing data to working group participants even though the AESO may not see it as adding value; participants need the numbers to be able to provide the actual data to customers
	 It will be helpful for the AESO to remain neutral on positions they may take early in discussions so that all parties have the opportunity to explore the options
	• AESO did most of the analytical work for the capacity market discussions; parties were satisfied with the analysis and having the data allowed parties to also do their own analysis; parties also noted that the AESO is in the best position to do the analysis
	Doyle noted that AESO has been directed to file the Transmission Tariff by Q1 2020. The AESO is intending to send a letter to the AUC to indicate that the work will be complete by Q2. Parties noted that it is more important to "do it right" rather than rush the work to be complete by Q1.
	A question was raised about whether the AUC could be invited to participate. AUC was invited early in the process and they declined to participate. DOE is updated after each meeting and they receive the presentation materials.
	It may be an option to invite DOE to join the TDAG for special sessions to discuss legislation. Specials sessions with the AUC to review analysis may also help to mitigate risks associated with filing.
