Process

Since mid-2018 the AESO has engaged with stakeholders through the Transmission Design Advisory Group (TDAG) on potential revisions to the currently approved 12-coincident peak (12 CP) methodology for the recovery of bulk and regional transmission costs. In January 2020, the AESO finalized and posted its *Stakeholder Engagement Framework* (Framework) on the AESO's website. In alignment with the Framework and in response to feedback that the AESO has received from the TDAG, the AESO is now transitioning the prior members-only TDAG engagement to broad industry stakeholder engagement. TDAG members have been notified of this change. In addition, the Transmission Tariff Working Group (TTWG) associated with TDAG has also been disbanded as of January 2020.

On Jan. 31, 2020, the AESO advised the Alberta Utiliities Commission (AUC) in its 2018 ISO tariff compliance filing and 2020 rates update application¹ that the AESO intends to address the 12 CP methodology by way of a tariff application to be filed by Sept. 30, 2020.

The AESO is commencing this broad industry stakeholder engagement with this notice to stakeholders.
