During the session, the AESO will summarize discussions and conclusions reached in the AESO's stakeholder consultation process to date and will present its view of how the costs of the capacity market should be allocated to loads, exports, and transmission losses using the weighted energy method as prescribed by legislation. The AESO will also present the time blocks, weights and preliminary terms and conditions developed through working groups in the stakeholder engagement process. Participants will have opportunities throughout the session to ask clarifying questions about the information presented.

Following the session, the AESO will provide an opportunity for written feedback on the content presented. The deadline for written feedback will be April 3, 2019. The AESO will post all feedback "as received" on <u>www.aeso.ca</u> and the names of the parties submitting feedback will be included in this posting. The AESO will consider this feedback in developing the ISO tariff application required for the approval to allocate the costs of the capacity market and in relation to our continuing work on tariff design for allocating bulk and regional transmission costs.
