¹Each settlement period is settled three times as part of the regular Energy Market settlement process cycle. Effective July 1, 2011 the timeline is one month (initial), two months (interim) and four months (final) after the end of the settlement period. Please refer to the Settlement Dates located on the AESO website under Market/Settlement/Settlement Dates for the detailed settlement timings.

²The Dispute Submission Period is a period of twenty business days following the issue date of the final energy market statement. If there is a disagreement with the settlement amounts after the final energy market statement date, then a written dispute must be filed with the AESO within the Dispute Submission Period. The rules regarding disputes can be found in the Market Participation Rules for the AESO.
